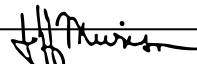

2. Article I of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and replaced with the following text:

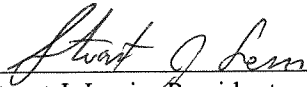
“The name of the corporation is West Raleigh Alliance, Inc.”
